6	SECTION 1. Title 10, Government Code, is amended by adding
7	Subtitle Z to read as follows:

10	CHAPTER 3000. GOVERNMENTAL ACTION AFFECTING RESIDENTIAL AND

12	Sec. 3000.001. DEFINITIONS. In this chapter:
13	(1) "National model code" has the meaning assigned by
14	Section 214.217, Local Government Code.
15	(2) "Governmental entity" has the meaning assigned by
16	Section 2007.002.
17	Sec. 3000.002. CERTAIN REGULATIONS REGARDING BUILDING
18	PRODUCTS, MATERIALS, OR METHODS PROHIBITED. (a) Notwithstanding
19	any other law and except as provided by Subsection (d), a
20	governmental entity may not adopt or enforce a rule, charter
21	provision, ordinance, order, building code, or other regulation
22	that:
23	(1) prohibits or limits, directly or indirectly, the
24	use or installation of a building product or material in the

1 construction, renovation, maintenance, or other alteration of a residential or commercial building if the building product or 2 3 material is approved for use by a national model code published within the last three code cycles that applies to the construction, 4 renovation, maintenance, or other alteration of the building; or 5 (2) establishes a standard for a building product, 6 7 material, or aesthetic method in construction, renovation, maintenance, or other alteration of a residential or commercial 8 building if the standard is more stringent than a standard for the 9 10 product, material, or aesthetic method under a national model code published within the last three code cycles that applies to the 11 12 construction, renovation, maintenance, or other alteration of the 13 building. 14 (b) A governmental entity that adopts a building code governing the construction, renovation, maintenance, or other 15 16 alteration of a residential or commercial building may amend a provision of the building code to conform to local concerns if the 17 amendment does not conflict with Subsection (a). 18 19 (c) This section does not apply to: 20 (1) a program established by a state agency that requires particular standards, incentives, or financing 21 22 arrangements in order to comply with requirements of a state or federal funding source or housing program; 23 24 (2) a <u>requirement for a building necessary to consider</u> the building eligible for windstorm and hail insurance coverage 25 26 under Chapter 2210, Insurance Code; 27 (3) a building located in a place or area designated

1 for its historical, cultural, or architectural importance and 2 significance that a municipality may regulate under Section 211.003(b), Local Government Code, if the municipality: 3 (A) is a certified local government under the 4 5 National Historic Preservation Act (54 U.S.C. Section 300101 et 6 seq.); or 7 (B) has an applicable landmark ordinance that 8 meets the requirements under the certified local government program as determined by the Texas Historical Commission; 9 10 (4) a building located in a place or area designated for its historical, cultural, or architectural importance and 11 12 significance by a governmental entity, if designated before April 13 1, 2019; 14 (5) a building located in an area designated as a 15 historic district on the National Register of Historic Places; 16 (6) a building designated as a Recorded Texas Historic 17 Landmark; (7) a building designated as a State Archeological 18 19 Landmark or State Antiquities Landmark; 20 (8) a building listed on the National Register of Historic Places or designated as a landmark by a governmental 21 22 entity; 23 (9) a building located in a World Heritage Buffer 24 Zone; and 25 (10) a building located in an area designated for 26 development, restoration, or preservation in a main street city 27 under the main street program established under Section 442.014.

1 (d) A municipality that is not a certified local government 2 under the National Historic Preservation Act (54 U.S.C. 300101 et 3 seq.) may adopt or enforce a regulation described by Subsection (a) that applies to a building located in a place or area designated on 4 or after April 1, 2019, by a municipality for its historical, 5 cultural, or architectural importance and significance, if the 6 7 municipality has the voluntary consent from the building owner. (e) A rule, charter provision, ordinance, order, building 8 code, or other regulation adopted by a governmental entity that 9 10 conflicts with this section is void. Sec. 3000.003. INJUNCTION. (a) The attorney general or an 11 12 aggrieved party may file an action in district court to enjoin a 13 violation or threatened violation of Section 3000.002. 14 (b) The court may grant appropriate relief. 15 (c) The attorney general may recover reasonable attorney's 16 fees and costs incurred in bringing an action under this section. 17 (d) Sovereign and governmental immunity to suit is waived 18 and abolished only to the extent necessary to enforce this chapter. 19 Sec. 3000.004. OTHER PROVISIONS NOT AFFECTED. This chapter does not affect provisions regarding the installation of a fire 20 sprinkler protection system under Section 1301.551(i), Occupations 21 22 Code, or Section 775.045(a)(1), Health and Safety Code. Sec. 3000.005. SEVERABILITY. If any provision of a rule, 23 24 charter provision, ordinance, order, building code, or other regulation described by Section 3000.002(a) is held invalid under 25 26 this chapter, the invalidity does not affect other provisions or 27 applications of the rule, charter provision, ordinance, order,

- 1 building code, or other regulation that can be given effect without
- 2 the invalid provision or application, and to this end the
- 3 provisions of the rule, charter provision, ordinance, order,
- 4 building code, or other regulation are severable.
- 5 SECTION 2. This Act takes effect September 1, 2019.
